

NOTICE OF INTENT For Soil Removal or Deposit Works Between 15-100 cu.m

The removal or deposition of soil is exempt from the soil application requirements under the Surrey Soil Conservation and Protection By-law, 2007, 16389 if for a given lot, the total quantity of soil removal or deposit proposed is greater than 15 cu.m but does not exceed 100 cu.m or 0.5m in depth, whichever the lesser, in any consecutive 12-month period. This exemption **does not** apply to soil or deposit works:

- 1. within a Development Permit Area as described in the City of Surrey's OCP:
 - Hazard Lands
 - i. Steep Slope Areas
 - ii. Flood Prone Areas
 - Sensitive Ecosystems
 - i. Streamside Areas
 - ii. Green Infrastructure
 - Farming Protection
- 2. that require the Agricultural Land Commission's Approval.

Written Approval from the Engineering Department must be provided prior to commencing the proposed works under this Notice of Intent.
