This Addendum is issued to provide answers to questions raised by potential Contractor for the above named project, to the extent referenced and shall become a part thereof. No consideration will be allowed for extras due to the Contractor not being familiar with this addendum. This Addendum No. 4 contains two (2) pages in total.

1. QUESTIONS & ANSWERS

REFER TO SCHEDULE A, SECTION 9 - MAINTENANCE SERVICE ITEMS

- Q1. <u>Item (j) Replace Register-</u> Sensus SRII Meter: What is the register size for the quantity of 50?
- A1. Answer: Remove that quantity from that line item.
- Q3. <u>Item (m) Replacement of Water Meter System</u>: Confirm the depth is 0 1.5?
- A3. Answer: (m) should read 0 m 1.5 m (depth)
- Q4. <u>Item (q) Meter Testing Field Testing</u>: Do the meters have a bypass and test port for field testing?
- A4. Answer: not all locations are equipped with test ports or by-passes.
- Q5. <u>Item (j) Replace Register Sensus SRII (digital)</u>: The manufacturer no longer produces SRII registers for the 38MM and 50MM sizes. Should those two sizes be omitted from the quote?
- A3. Answer: Yes. Remove 38mm and 50mm from this quote.
- 2. REFER TO SCHEDULE A SCOPE OF SERVICES

2.1 Water Meter Maintenance Program

Water meters requiring maintenance under program work will be provided to the Contractor in monthly maintenance service lists and work orders generated by the City's work management system (Cityworks).

Monthly lists provided by the city must be completed 2 months after receiving the list of locations and updates on the progress must be provided weekly.
