## **INFORMATION FOR CONTRACTORS**

Contractors are advised that Addendum No.1 to 1220-060-2024-006 is hereby issued by the City. This addendum shall form part of the contract documents and is to be read, interpreted and coordinated with all other parts. The following information is provided to answer questions raised by Contractors for the above-named project, to the extent referenced and shall become a part thereof. No consideration will be allowed for extras due to the Contractors or any sub-contractor not being familiar with this addendum. This Addendum No. 1 contains 2 (two) page/s.

## **QUESTIONS AND ANSWERS:**

- Q1. In Section 12 Communication (e), the emergency services response time is stated to be within two hours for time-sensitive and emergency services, but in Table 7 Response Times the maximum response time is stated to be one hour, please confirm the required emergency services response time.
- **A1.** The Contractor is expected to be on site within 2 hours, and this inconsistency is hereby amended as follows:

Delete Schedule B – Application for a Standing Offer Agreement in its entirety and substitute with the new Schedule B – Application for a Standing Offer Agreement Add No. 1 as attached with this Addendum No. 1.

**Q2.** What kind of debris is "non-asbestos containing material" in the table below? Is it usually general garbage and/or construction debris?

- **A3.** All drywall including the presence of other material is categorized as asbestos containing. City staff conduct a preliminary site check to confirm asbestos containing material at the pickup location.
- Q4. What type of work/conditions will trigger emergency services?
- **A4.** Sites located on roadways, large volumes of material, or material in environmentally sensitive areas will require emergency service.
