INFORMATION FOR CONTRACTORS

Contractors are advised that Addendum No. 2 to 1220-060-2024-006 is hereby issued by the City. This addendum shall form part of the contract documents and is to be read, interpreted and coordinated with all other parts. The following information is provided to answer questions raised by Contractors for the abovenamed project, to the extent referenced and shall become a part thereof. No consideration will be allowed for extras due to the Contractors or any sub-contractor not being familiar with this addendum. This Addendum No. 2 contains 2 (two) pages.

QUESTIONS AND ANSWERS:

- **Q1**. We are looking for clarity on the "Rates for Hazardous Waste Collection". The labour rate includes the following:
 - 1. Driving time to the site
 - 2. Time associated with waste collection
 - 3. Driving time to the dump site

The rates would differ for Asbestos containing material vs. non asbestos containing material.

We are curious on how to provide you with a rate on the hazardous waste collection and disposal in Table 3. Would you simply request the 'actual cost' (i.e. receipt) of disposal by the collection

site (e.g. Vancouver Landfill) or is your expectation that we would hold the hazardous waste on our site till there is sufficient material to dispose?

For example, if 1 piece of drywall is collected, is the city expecting us to dispose it at the landfill immediately or hold it until enough has been accumulated from other similar collections to dispose in 1 bin?

- **A1.** Please refer to Section 3 and 4 of Schedule A. Furthermore, Applicants should specify their proposed disposal process for asbestos containing material and non-asbestos containing material.
- Q2. Is there a safety requirement to have at least two (2) people on site upon collection?
- **A2.** The Applicant shall comply with Section 18 of the Standing Offer Agreement and Section 5 of Schedule A.
- **Q3**. Could you kindly provide the average number of emergency services performed for 2023/2024 and the corresponding total hours of work?
- **A3.** Emergency callout data is not available and emergency hours of work fluctuate annually.

All Addenda will become part of the Contract Documents.
