QUESTIONS AND ANSWERS:

- Q1. What is the construction budget? Is this based on grant funding available per child? If so, what is the grant amt per child?
- **A1.** The grant funding covers multiple items besides the renovation and the final budget has not been finalized by the City.
- **Q2**. The proposed timeline is extremely tight. Are you open to extending the project timeline to allow for more stakeholder engagement, licensing review and documentation time?
- **A2.** The goal is to issue for tender in early January 2024 as per item 3 Estimated Timeline in Schedule A Scope of Services.
- **Q3**. Will you require more than 1 design option in Schematic Design and/or do you want multiple design options to be costed?
- **A3.** 1 design option would be optimal, maximum 2.
- **Q4**. Can we assume the concept plan will not change substantially?
- **A4.** As per item 2 Scope of Work in Schedule A Scope of Services.
- Q5. Has there been any stakeholder engagement that has been done and if so can it be provided?
- **A5.** Stakeholder engagement was done during the study in 2022, and it is reflected in the feasibility plans.
- **Q6**. What stakeholder engagement do you anticipate will be required from the Architect/Design team for the project?
- **A6.** Refer to item 2 Scope of Work in Schedule A Scope of Services (e.g. a.7)
- Q7. Is there an anticipated # of workshops/presentations?
- **A7.** Refer to item 2 Scope of Work in Schedule A Scope of Services (e.g. a.9). We expect regular meetings with the project team that involves stakeholders, no workshops are required.
- **Q8**. Are preparation of formal meeting minutes and agendas required by the Consultant?
- **A8.** Yes, minutes and agendas during the design phase, and start-up meeting with GC. Refer to item 2 Scope of Work in Schedule A Scope of Services (e.g. a.6)
