#### B. DELEGATIONS

## 1. Request for Squash Courts in the City of Surrey

P. Mehat, J. Currie and D. Steyn

The delegation provided a presentation on a proposal for the development of squash courts in Surrey. The highlights included an overview of racket sport in B.C and how it promotes a healthy lifestyle for Surrey residents. The delegation provided many examples of the growing sport and an overall study on squash courts available in the lower mainland.

G. Bhurji joined the meeting at 6:15 p.m.

Following the presentation the Chair opened the floor to questions/comments from the Committee:

- What is the number of squash courts that are available both privately and publicly? The delegation advised that there is a diverse range of clubs, some run-in partnership with the city for community engagement and some operate privately nonprofit with city participation, although they are not owned by the city;
- What are the current age statistics of participants in B.C playing squash? The delegation shared that the age range of players in the rankings varies between men and women. There is a wide age range for junior and senior squash tournaments, starting from eight years old;
- The Chair inquired about recommendations for the squash court's placement location to which the delegation provided.

The General Manager of Parks, Recreation and Culture noted that staff will conduct an inventory of public courts and public-non-profit partnerships facilities in the lower mainland and report back to the committee regarding potential future opportunities for facility develop in Surrey at a future meeting.

## 2. Cricket Growth and Community Engagement

E. Hassan, Last Man Stands Canada

The delegation provided a PowerPoint presentation on the importance of the growth and needs of amateur cricket in Surrey through Last Man Stands Canada DEI Foundation.

The Chair thanked the delegation for the presentation and opened the floor to questions and comments from the Committee:

- Cricket BC prepares the wickets and there is one natural turf in Surrey for athletes that require a professional ground;
- Traditional cricket matches can be many hours long throughout the day and evening.

The General Manager of Parks, Recreation and Culture informed that the City currently has thirteen utilized grounds. A new field is being added at North Surrey Community Park located at 97A Ave and 155B St. Two all weather gravel fields at Royal Kwantlen Park have recently been renovated to accommodate tapeball cricket and support the growth of cricket. It was noted that staff will review and reassess allocations due to the rapid growth in utilization for cricket grounds and report back at a future meeting.

#### C. STAFF PRESENTATION

#### Accessibility Action Plan 2024

Staff provided a PowerPoint presentation on the City's updated Accessibility Action Plan that will go to Council on April 8, 2024, to seek endorsement. The Plan outlines the City's commitment to improve accessibility, in compliance with the Accessible British Columbia Act. Highlights included:

- The Accessible Canada Act (ACA) was passed in 2019, with the goal to make Canada barrier free by January 1, 2040.
- Council endorsed the draft Accessibility Action Plan on September 25, 2023. Under the ABCA, the City is required to:
  - Establish an accessibility advisory committee;
  - Develop an accessibility plan that outlines how it will identify and prevent barriers for people interacting with or working in local government. The plan must be reviewed and updated at least once every three years;
  - o Create a public feedback mechanism.
- Key focus areas of the Plan include:
  - o Inclusive service design and delivery;
  - o Accessible communication and engagement;
  - o Built environment and public spaces;
  - o Accessible employment practices;
  - o Accessible procurement.
- Community feedback that was received in fall 2023, aligns with the Plan;
- The Plan will be reviewed and updated once every three years;
- Discussion ensued on sensory sensitive individuals that are included in the Plan and considered in delivery of the programs and events.
